

## Steroid Use in Pediatric Fluid and/or Vasoactive Infusion Dependent Shock – Pilot Study

### RECRUITMENT UPDATE

As of March 23<sup>rd</sup>, 13 patients have been enrolled into the STRIPES study, and there have been no issues with the use of the deferred consent model. To date, patients have been enrolled at CHEO (8), Hamilton (4), and Ste. Justine (1). Please continue to remind PICU staff at your site about the STRIPES study. The site research assistant/coordinator should be notified as soon as a patient is started on any vasoactive infusion for the treatment of shock.

### OPEN-LABEL STEROID USE IN STRIPES PATIENTS

Please reinforce this message with the PICU staff at your site: *"We strongly encourage clinicians to only consider use of open-label steroids in patients with fluid refractory and catecholamine resistant shock as per the ACCM 2013 guidelines. That is, patients who are no longer responding to fluids and are on dopamine 10 mcg/kg/min and epinephrine 0.05 to 0.3 mcg/kg/min or equivalent and still not stabilizing."*

An updated SOP containing this wording was recently circulated and is available on the study website.
